

CONDITONS OF SALE

1. ORDERS

Orders must be given in writing and when accepted shall be subject to these standard Terms and Conditions and no other.

2. CHANGE OF PRODUCT SPECIFICATIONS

Leon Technology Limited policy is one of continual improvement and Leon Technology Limited reserve the right to make reasonable changes to product specifications at its discretion during the completion of purchase orders.

3. DELIVERY

Leon Technology Limited will use its best endeavours to deliver by the date specified but shall be under no liability what so ever for delay or consequence thereof however caused. Leon Technology Limited may decline to deliver until payment is made.

4. SHORTAGES

Claim for shortages or damages to goods will not be accepted unless notified to Leon Technology Limited within fourteen days from the date of despatch of the goods in writing. Full details of the circumstances of any loss must be given and packaging etc retained. Admitted shortages will be replaced at the previously invoiced price.

5. PRICES

All prices quoted are ex. Works and include packaging. Where applicable carriage and insurance will be charged extra.

6. DUTIES AND TAXES

If prior to the date of delivery and after acceptance of the orders there shall be any variation in any duty or taxes arising for any reason the price may be reviewed at Leon Technology Limited discretion.

7. PAYMENT TERMS

Credit and Debit Card or Bank Transfer unless credit terms agreed.

8. CREDIT TERMS (Where agreed)

Payment for all sales shall be made within 30days of the date of invoice for the goods. Payment shall be by Bank Transfer to ensure receipt into Leon Technology Limited account within 3 days of the payment date. Terms of payment is the essence of this contract. Interest maybe charged at an annual rate equal to the Bank of England minimum lending rate plus 3% on all outstanding balances. The property of the goods shall not pass until payment therefore has been made in full.

Until such payment is made in full any monies received on any sub-sales shall be held by the buyer as agents for Leon Technology Limited and separately designated.

Leon Technology Limited is granted the right to enter into the buyer's premises to recover any goods not yet paid for which shall be kept separate from all other goods in the buyer's premises.

9. WARRANTY

United Kingdom – All products sold by Leon Technology Limited within the United Kingdom (UK) are warrantied free from defect caused by faulty material or workmanship for a period of twelve months from the date of despatch.

Export – All products shipped outside the U.K. include an allowance within the pricing structure for the distributor to take total responsibility of warranty repairs. Parts however will be supplied on a cost basis to assist with service requirements.

10. TECHNICAL ADVICE

Leon Technology Limited warranty shall not be effected by and no obligation or liability shall result from Leon Technology Limited providing technical advice or service in connection with the customers order or the goods supplied.

11. REMEDIES AND DAMAGES

Leon Technology Limited shall not incur any liability under the above warranty unless:

- a) Leon Technology Limited is promptly notified in writing upon discovery by the customer such that goods do not conform to warranty, and
- b) The alleged defective unit is returned to Leon Technology Limited carriage pre-paid, and
- c) Examinations by Leon Technology Limited of the unit shall confirm that the alleged defect exists and has not been caused by miss-use, neglect, method of storage, faulty installation, handling, testing or repair, or by alternation or accident. Leon Technology Limited shall not be limited to replacing, repairing or issuing credit at its option for any goods returned within the above-mentioned period.

Leon Technology Limited shall not be liable for incidental or consequential damages for any breach hereof including but not limited to costs of removal and re-installation of goods, loss in goodwill, loss of profits or loss of use.

12. SUBJECT TO THE LAWS OF ENGLAND

This agreement shall be governed by and construed in accordance with the law of England.
